As I write this, the nation's focus is on the Houston and the Gulf Coast area, and the devastation wreaked by Hurricane Harvey. Many expect that federal government agencies will step in and assist with the overwhelming clean-up after the flood waters subside. Local government officials know, however, that the initial response, indeed, most of the follow-up, is the responsibility of the local government – police and fire, emergency management and human services agencies, even the animal shelter. That's why, at the local level, we plan and test, and then plan and test some more, not only for emergency response, but associated issues, such as storm water requirements for new development and redevelopment.

Hopefully, this region never will experience a storm like Harvey, but we have had our own Hurricane Isabel, Tropical Storm Lee, and the derecho in recent years, so updating both county and personal emergency plans is a good idea. Be sure you have emergency supplies stashed where they are easily accessible, make a plan with your family, have extra batteries, medications, and food that does not need cooking (for your pets, too). Keep your portable devices powered up, and watch the fuel level in your vehicle. During an emergency declaration is not the time to try to find a service station. When the electricity goes out, the fuel pumps won't work! Same thing goes for cash – ATM machines don't work in a power outage.

Building Resiliency, both internally and externally, will be the focus of a Resiliency Summit I am hosting on **Thursday**, **October 12**. More information will be available soon, but mark your calendars for the event, which will feature a lot of helpful information for you and your family – and our community – to be safe and prepared.

FCPS Hosts Community Meeting to Discuss Renaming J.E.B. Stuart High School – The Fairfax County Public Schools will host a public meeting to gather names for consideration, along with the opportunity for presentations, questions, and discussion, on **Saturday**, **September 9** at 10 a.m., at the J.E.B. Stuart High School Auditorium, 3301 Peace Valley Lane in Falls Church. As outlined in Regulation 8170, residents in the J.E.B. Stuart High School pyramid may vote for the name of the high school on **Saturday**, **September 16**, 10 a.m. to 6 p.m. Only one vote per household. After review of the community's recommendations, the Division Superintendent will formulate a recommendation consisting of one or more of the most popular choices, according to community input. The Division Superintendent shall then transmit the recommendation to the School Board, which is solely responsible for consideration and action. The Fairfax County Planning Commission recommended approval of this application on Thursday, June 29, 2017. The Board of Supervisors will hold a public hearing for a final approval of this application on **Tuesday, September 12**, in the Board Auditorium, 12000 Government Center Parkway in Fairfax. OEM Reminder: Hurricane Season Is Here - Are You Prepared? - The Atlantic hurricane season is in effect through November 30. If you have not done so already, update emergency plans, refresh supplies for your family and pets, and be ready should a tropical storm affect our region. The Fairfax County Office of Emergency Management is responsible for coordinating

preparedness, response, and recovery efforts for significant emergency events that may occur in our community. Sign up for Fairfax Alerts at <u>www.fairfaxcounty.gov/alerts</u>, or call 571-350-1000. <u>Reports of Underage Solicitors</u> – The Fairfax County Police Department and the Department of Cable and Consumer Services, Regulation and Licensing Branch, has received reports that children, ages 10 to 15, are going door to door in Fairfax County illegally soliciting donations by selling candy and other items. Often these children have no affiliation with any Fairfax County school, and they are not raising money for any school activities. The children are driven to Fairfax County from other areas, and dropped off in neighborhoods during the day or night to solicit donations door to door. Please note that it is against the law for children under the age of 16 to solicit in Virginia, except for children who, under adult supervision, are participating in a bona fide fundraiser for a local school or registered charitable organization, such as Girl Scouts or Boy Scouts. If this is occurring in your neighborhood, please call the Fairfax County Police's non-emergency number 703-691-2131 immediately to report this activity to the dispatch staff. Also report this activity to Henri Stein McCartney, Chief of the Regulation and Licensing Branch, Department of Cable and Consumer Services at 703-324-5845, or send an e-mail to Henri.SteinMcCartney@fairfaxcounty.gov. Please remember that legitimate door-to-door solicitors will have a peddlers license issued by Fairfax County that has a picture of the solicitor and an expiration date on the front of the license. Disposing of Expired Prescription Medications – Here are six reasons why you should properly dispose of prescription medications:

- 1. Unused or expired prescription medications are a **public safety issue, leading to accidental poisoning, overdose, and abuse**.
- 2. The majority of teenagers abusing prescription drugs get them from family and friends and the home medicine cabinet.
- 3. **Pharmaceutical drugs can be just as dangerous** as street drugs when taken without a prescription or a doctor's supervision.
- 4. The **non-medical use of prescription drugs ranks second** only to marijuana as the most common form of drug abuse in America.
- 5. Unused prescription drugs thrown in the trash can be retrieved and abused or illegally sold.
- 6. Unused drugs that are flushed **contaminate the water supply**. <u>Proper disposal of</u> <u>unused drugs</u> (<u>www.fairfaxcounty.gov/hd/dontflush</u>) saves lives and protects the environment.

Drug Disposal Kits are available at Health Department Offices and other locations. To safely dispose of prescription meds, you can **pick up a biodegradable drug disposal kit**, at any of our <u>Health Department's clinics</u> (www.fairfaxcounty.gov/hd/hdclinicsite.htm), or through

the <u>Fairfax-Falls Church Community Service Board's REVIVE! classes</u> (www.fairfaxcounty.gov/news2/learn-how-to-revive-someone-from-a-drug-heroinoverdose). Call clinics to confirm availability of the kits.

Partnership with Schools Gives New Life to Old Computers – Thanks to an innovative new partnership between the Foundation for Fairfax County Public Schools, the <u>Office of Public</u> Private Partnerships, the <u>Department of Information Technology</u> (DIT), and the <u>Virginia Student</u> <u>Training and Refurbishment Program</u> (VA STAR), computers being replaced in county offices will have new lives in the homes of students. Starting this fall, the **county will donate** used computers to VA STAR; students in **after-school technology clubs will refurbish them**; and then **the computers will be donated to FCPS students in need**. The after-school program, currently supported at **seven of our middle and high schools**, teaches students how to install new hard drives and RAM, replace missing and broken parts, and install operating systems and security software. VA STAR Club members gain valuable hands-on technology experience, while giving back to the community. The Foundation for FCPS is the coordinator for the program in Fairfax County.
