A few items of information for you or your association newsletter:

The Board Corner: Perspectives from Penny – County Executive Bryan Hill will present his proposed FY2019 county budget on **Tuesday, February 20**. Most of the development of the proposed budget was done before he assumed office in early January, but the final package will be his proposal. The Board of Supervisors will spend March and April examining the recommendations, and making changes, before adoption of the revised budget on **Tuesday, May 1**. The Board of Supervisors' budget discussions are broadcast live on cable Channel 16, and also on demand at <u>www.fairfaxcounty.gov</u>.

By law, Fairfax County must adopt a balanced budget every year. This is in marked contrast to the inability of the federal government to agree on a budget, relying instead on the fits and starts of multiple Continuing Resolutions, or CRs, to keep the federal government running for a few weeks or months at a time. Local governments can't, and don't, operate that way. Local taxpayers rightly expect credibility, consistency, and common sense from their local elected officials in the use of local tax dollars. Leaders are elected to make the hard decisions, not abrogate that responsibility by kicking it down the road.

Elsewhere in this newsletter is information about the Alexandria-Lincolnia Lions Club. If you have eyeglasses or hearing aids that you no longer need or use, consider dropping them into the Lions Club donation box in my office. Your used specs can provide improved eyesight to those in need.

Some special February dates prompt reminders: Get those flowers and chocolates ready for Valentine's Day, on **Wednesday, February 14**. Then, for Presidents' Day, observed this year on **Monday, February 19**, you can visit Mount Vernon (free admission), home of our first president, George Washington, and learn more about the fascinating early history of Fairfax County.

File Virginia taxes before the deadline on Tuesday, May 1. AARP volunteers provide walk-in services on: Mondays and Thursdays from 1 to 8 p.m.; Tuesdays, Wednesdays, and Fridays from 9:30 a.m. until 1 p.m.; Saturdays from 9 a.m. until 1 p.m. Please note: No Tax-Aide service on President's Day, Monday, February 19, 2018. All returns are filed electronically. Bring documents, such as last year's tax return, a photo ID, and all Social Security cards. Residents with illnesses or infirmities, which confine them to their homes, may schedule appointments with AARP for tax preparation services by calling 571-766-6268. Volunteers Needed for DFS VITA Program – The Fairfax County Department of Family Services (DFS) coordinates a regional, volunteer-run Volunteer Income Tax Assistance (VITA) Program, which provides free tax assistance to individuals and families with low incomes. Volunteers are needed now to April 2018 for three to five hours, once or twice a week, at multiple locations throughout Northern Virginia. No tax experience is necessary for interpreters and greeters. Tax preparers and screeners should have experience preparing a tax return, and additional training will be provided. Classroom and/or online training available, and all tax preparers must pass an IRS certification test. VDOT Continues Its Readiness During Snow Season - The Virginia Department of Transportation (VDOT) continues its readiness for snow season with plow-tracking technology, expanded monitor programs, and a one-stop shop for online resources that is available for residents to use. VDOT has budgeted \$84.9 million for snow removal in Northern Virginia this winter, and the agency's state and contracted fleet has salt, brine, sand; and 4,500 vehicles (97 percent of fleet is contracted) to mobilize.

Highlights for Snow Season 2017-2018

- **One stop-shop for resources:** Visit <u>www.virginiadot.org/novaemergency</u> to access all of VDOT's online information resources, including important messages and updates, news releases, and links to the <u>customer service center</u>, <u>511</u>, and <u>vdotplows.org</u>.
- **Monitor program:** This year, 180 VDOT employees will ride the roads to monitor road conditions and snowplow progress, and more than 30 employees will monitor remotely via the automatic vehicle locator (AVL) equipment.

How You Can Help:

- Monitor forecasts frequently;
- Adjust commutes, telework, and avoid driving if possible;
- Park in driveways or park on the odd-numbered side of the street.
- Do not shovel driveways until plows have come through;
- Have enough fuel, wiper fluid, proper tires, medication, and an emergency car kit;
- Be patient: crews need time and room to work.

<u>Governmental Center</u> - Supervisor Penny Gross, in collaboration with the Department of Tax Administration (DTA), is hosting free tax relief workshops on March 7 and 9, 2018, from 9 a.m. to 12 noon both days, at the Mason District Governmental Center, 6507 Columbia Pike in Annandale. DTA staff will be on-site to assist residents with completing the 2018 Tax Relief application form and answer questions. No appointment is necessary. Bring your 2017 tax returns or proof of 2017 gross income from all sources, and all asset information as of December 31, 2017. Real estate tax relief is available for older adults and people with disabilities who meet certain qualifications. Qualified residents also may be eligible for car tax and rent relief. Mason Matters! The Television Show – Heart disease and strokes kill one in three women each year – more than all cancers combined. There are even greater disparities within the African American and Hispanic population, where heart disease and stroke rank as the number one killer of women. In Fairfax County, we are fortunate to have many outstanding physicians and private medical facilities in the community to meet women's health needs, especially against heart disease. Fairfax County also has several non-profit public organizations that help women achieve heart health. One such resource is Mason District's own Culmore Clinic. Founded in 2007, the Culmore Clinic is a non-profit healthcare clinic serving low-income adults in the Bailey's Crossroads community. The clinic is supported by a diverse group of interfaith volunteers, healthcare providers, and donors, and offers compassionate medical care, counseling services, and referrals for specialists. The Quick 411 – I am planning a home renovation this spring and I would like to hire a contractor to do the work. I want to verify that my contractor has a license, and I have other related questions. Does Fairfax County offer information that I can utilize before I begin my project? Yes. If the project you are planning is valued at \$1,000 or more, the person doing the work must have a valid Virginia Contractor's License issued from the <u>Department of</u> <u>Professional and Occupational Regulation (DPOR)</u>. Licenses are issued in one of three classes; A, B, or C. This determines the dollar amount of the contract. Licenses also are issued with classifications and specialties that identify the type of work that may be performed.
