A few items of information for you or your association newsletter:

**The Board Corner: Perspectives from Penny** – March is forecast to come in like a lion (wind and rain, not snow!), but the County Executive's release of the proposed FY2019 county budget could be characterized as more like a lamb, as many county priorities – public education, retaining and rewarding hardworking county employees, gang prevention, addressing the opioid crisis, and early childhood initiatives – are recommended for funding. To continue with the metaphor above, the lion's share of the county budget supports schools. The proposed school transfer is \$2.26 Billion, or 52.8 percent of the county budget, while an additional \$88.1 million in county funds supports programs such as Head Start, school health, crossing guards, school resource officers, and after school programming. To meet these overarching priorities, County Executive Bryan J. Hill has recommended a real estate tax rate increase of 2.5 cents, or \$1.155 per \$100 valuation.

Housing values in Fairfax County are enjoying a bit of an uptick; the FY2019 residential equalization (average appreciation in value) is 2.17 percent. Non-residential equalization (apartments, office, retail, hotels) is 3.79 percent, reflecting slightly reduced office vacancies. Overall, in Mason District, property values remained fairly stable, although a few neighborhoods experienced higher increases, based on comparable sales.

The Mason District Budget Town Meeting will be held on Thursday, March 15, at 7 p.m., at the Mason District Governmental Center, 6507 Columbia Pike in Annandale. Mr. Hill and Chief Financial Officer Joe Mondoro will present the budget, followed by a question and answer period. Public hearings about the proposed budget are scheduled for April 10, 11, and 12, in the Board Auditorium of the Fairfax County Government Center, 12000 Government Center Parkway in Fairfax. <u>Construction Begins on Route 50 Pedestrian Initiative Improvements</u> – Fairfax County in coordination with the Virginia Department of Transportation, will begin construction of 10 projects designed to increase pedestrian safety, connectivity, and accessibility along Route 50/Arlington Boulevard, between Jaguar Trail to east of Patrick Henry Drive in the Seven Corners area of Mason District. One project beginning construction this month will reconfigure



the center median to restrict left turn access onto Route 50 from Woodlawn Avenue and Wayne Road. A high visibility pedestrian crosswalk on the east side of Route 50 and Woodlawn Avenue will connect to ADA accessible curb cut ramps, sidewalks, and bus stop pads. Active construction is scheduled Monday to Thursday, between 9:30 a.m. until 3 p.m., and Friday between 9:30 a.m. to 2 p.m.; the project is projected to be completed this fall. <u>Water Main Replacements Scheduled along Gallows Road in Annandale</u> – As part of Fairfax Water's program to improve water service, selected water mains will be replaced along Gallows Road, in the vicinity of Justine Drive and Village Drive in Annandale. Fairfax Water's contractor, Casper Colosimo and Son, Inc., will begin work within the next several weeks. There may be water service interruptions for short periods during construction. Traffic flow on Gallows Road, Village Drive, and Justine Drive will be maintained, and affected residents will have access to their homes during construction.
