### Don't Forget to Vote Tuesday, November 3th

The Virginia gubernatorial election of 2009 is scheduled to take place on November 3, 2009. The election will choose the next Governor, Lieutenant Governor, and Attorney General of the commonwealth of Virginia. The winners will be inaugurated in January 2010 and will serve until January 2014. The current Governor, Democrat Tim Kaine, is not eligible to run due to term limits established by the Virginia Constitution, though others in the state's executive branch are not restricted.

### **Phone Book**

The Board's efforts to pull together a phone book in 2009 were unsuccessful; only about 30% of Leewood residents responded to our request for information. We know from past experience that a Leewood phone book/directory is very handy, so we are still interested in trying to get one put together and published.

Homeowners, when you receive your annual meeting package in 2010, it will contain a form that will give three options:

- 1) Verify that the information in the 2007 directory is accurate for listing in the 2010 directory
- 2) Provide new information for listing in the directory
- 3) Indicate that you do not wish to be listed.

Again, we encourage all homeowners to list at least their name and an e-mail address. Offsite owners especially are asked to please provide an e-mail address, and an offsite mailing address. This information will make it much easier to communicate when the need arises. We sincerely hope a much larger number of homeowners and residents provide information and agree to be listed.

# **Trash Holiday Schedule and Recycling**

**Christmas Day** (Friday December 25) - Office is closed and **NO** services will be provided. If your trash collection falls on this day, your service will resume on Tuesday December 29th. NOTE: Please do not put your trash out on Christmas Day.

**New Year's Day** (Friday January 1, 2010)\_— Office is closed and no services will be provided. If trash collection falls on this day, your service will resume on Tuesday, January 5<sup>th</sup>. NOTE: Please do not put your trash out on New Year's Day.

Yard Debris Collection: Ends December 31<sup>st</sup>

Christmas Tree Collection: Christmas trees will be collected on your regular yard debris collection day. We ask that all tinsel and decorations be removed. Please do not place trees in plastic bags. Christmas trees will be collected on the lst two Wednesdays in January.

Inclement Weather: Trash will not be collected if ADS deems roads unsafe. If cancellation occurs, services will resume on the NEXT regularly scheduled collection day. Please keep in mind that it is the County and State roads that will affect our pick-up. Since Leewood has a private snow removal contractor, our streets are usually in better shape earlier than Braddock or Backlick Roads and our contractor must travel from Manassas to Leewood to pick up trash.

**Recycling**: There have been some changes in recycling. ADS has provided the attached flier that outlines these changes.





### **Your Association At Work**

What is really required to manage Leewood? The following article provides a description of the duties of the President; how the position is defined in our covenants, but more importantly, what the Leewood President actually does with regard to the day-to-day management of Leewood. In the next issue of The Leewood Times, there will be articles describing the duties of the Secretary, Treasurer, and the Grounds and Maintenance Committee.

#### **President**

My name is Janet Rourke and I have been serving on the Board since August 2006 and as President since October 2006. As defined by Article XI of the By-Laws, "The President shall preside at all meetings of the Board of Directors; shall see that orders and resolutions of the Board are carried out; shall sign all leases, mortgages, deeds and other written instruments and shall co-sign all checks and promissory notes." The President also presides at the annual business meeting. The term of office is three years and there is no limit on how many terms a President may serve.

There are a lot of activities encompassed in this formal definition. I participate in the negotiation of all Leewood contracts including interviews of bidders. I liaison with our law firm on all legal cases and testify at any court proceedings. I manage the activities of the Association to ensure that each officer and committee chair are fulfilling the duties required by their office. I initiate the five year reserve study and work with the consultant and the Board to prepare a plan for the management of our reserve funds. I sign all contracts, audits, income tax forms and other documents pertaining to Leewood. annual meeting package, annual assessment memorandum and other documents for clearance by the Board. I direct the preparation of our annual budget and work with the Board and our volunteer in finalizing it. In addition, I participate in other responsibilities of the Board which can include grounds clean-up, fence repair, removal of small trees, etc. In conjunction with other Board members and volunteers, I supervise street and sidewalk repair and facilitiated such projects as installation of lights and mailboxes. All in all, the position provides an opportunity to serve Leewood, is never boring and has the added pleasure of getting to know Leewood homeowners through interaction on various projects and issues. This position will become vacant through term expiration in March 2010.
